## **JOB DESCRIPTION:**

The Medical Officer provides immediate and long-term healthcare needs for inmates in the custody of the Detention Center. Must possess a working knowledge of the specialty areas of medical protocol such as public health, infectious disease, emergency medicine, OB/GYN and mental health. Provide care for difficult patients and issues of intensive medical care.

## **EXAMPLES OF TASKS PERFORMED:**

- 1. Provides both emergency and non-emergency medical care to inmates.
- 2. Administers prescribed medications.
- 3. Observes and assesses health needs of inmates.
- 4. Participates in planning and implementation of all health care for inmates.
- 5. Medically clear inmates in booking area.
- 6. Responds quickly to calls for assistance to all areas of the Detention Center as needed.
- 7. Charts in medical files.
- 8. Conduct TB testing of inmates.
- 9. Provide blood draws as ordered by contract physician or court order.
- 10. Maintains records of drugs and medications

- 11. Assist in medical care plans of inmates.
- 12. Performs related work as assigned.

## **REQUIREMENTS:**

- 1. Must be a State of Texas licensed LVN, RN, or EMT-P.
- 2. Must become licensed as a Correction Officer through TCOLE (training provided)
- 3. Must be 18 years of age
- 4. Must be a US citizen
- 5. Must have graduated high school or completed GED
- 6. Must possess a valid Texas driver's license
- 7. Must not have been convicted of a Class B misdemeanor within the last ten years
- 8. Must never have been convicted of a Class A misdemeanor or Felony
- 9. Must never have been convicted of a family violence offense of any level
- 10. Ability to read and write the English language
- 11. Ability to bend, lift, grasp, climb, use fine hand-eye coordination, push and pull, and endure long periods of standing or sitting
- 12. Ability to remain calm under stress
- 13. Ability to understand and assist in solving work-related issues
- 14. Ability to respond to telephones, two-way radios, and other auditory stimulation
- 15. Ability to evaluate and interpret information and to make independent decisions
